## CONCRETE YOUTH SPORTS ASSOCIATION COACH'S CODE OF CONDUCT

Implemented: 6/1/21    Revised: 09/05/25

1. No Coach shall exhibit any display of unsportsmanlike conduct. (Debasing players, coaches, etc.)
2. No Coach shall use vulgar language or obscene gestures.
3. No Coach shall give argument or make any comments, on any judgment calls. An appeal should be asked for, when questions arise.
4. No Coach should be argumentative or abusive in a rule dispute. A conference with an official should be asked for, and the disagreement discussed calmly.
5. No Coach will be allowed to have alcohol or any other controlled substances of any type, on the premises, before, during or after any game or practices.
6. No Coach shall report to any games or practices while intoxicated.
7. No tobacco or vaping use on the field at any time, during practices or games.
8. Coaches, who violate these codes or any CYSA Codes of Conducts, shall be ejected from the game or practice. Board of Directors action may be required.
9. Coaches must ensure that only athletes who are officially registered with CYSA and assigned to their specific team or program participate in practices, games, or tournaments. Siblings, friends, or unregistered guests are not permitted to join practices, scrimmages, games, or other team activities at any time.
10. Coaches with two (2) ejections, during the season, will be removed from the program at the President's order.
11. All coaches are responsible for paying fines that are assessed against them.
12. All coaches will adhere to and enforce all CYSA guidelines.
13. All coaches will follow the provided Concussion Action Plan and make decisions in the players best interest.
14. As a coach, you are responsible for any fines, fees, or penalties incurred as a result of your actions or decisions, including those related to conduct, roster violations, or failure to follow league or organizational rules. These fines must be paid in full and in a timely manner.

Wrestling Coaches:

### **Western Washington Kids Wrestling League (WWKWL)**

- I acknowledge and agree to stay in the bleachers during tournaments. Any issues I have with match outcomes or discrepancies will be brought to the Cement City program manger only. It is at

their discretion to bring it up to officials or the head table. I will not harass, disrespect, or confront an official or tournament volunteer.

- I acknowledge that during tournaments I will be responsible for making sure my athlete is treating the event site with respect and staying within the event area. (No wandering halls, climbing on school property, or defacing school property.)
- I understand that violating these terms could result in the suspension of my athlete from future competitions.

If there is a compliance infraction of the above Code of Conduct, the procedure for remediation will be as follows:

1. The player, parent or board member will be contacted by the Manager for Program or a CYSA Board Member.
2. The Program Manager or board member will schedule a time to meet with the coach, player, board member to discuss the infraction. The meeting will take place as soon as possible after the infraction is incurred.
3. The Program Manager or Board Member will evaluate and offer an opinion to the CYSA Executive Board for a vote – this could result in penalties, expulsion, or suspension from the program depending upon the infraction.
4. Upon a vote from the CYSA Executive Board, the Program Manager, coach, player, parent, and/or board member will be notified of the Board's position and the appropriate action will be followed.
